Executive Director Lambert commented that the “Communications” policy and the “Review of Facilities Contracts or Financing Agreements for Charter Schools” policy were posted for more than thirty days. The “Communications” policy received no public comment, but the “Review of Facilities Contracts or Financing Agreements for Charter Schools” received multiple comments.

Request for Enrollment Cap Flexibility for SY2020-2021: *Utah Connections Academy and Utah Virtual Academy*

Chair Tonks declared a conflict of interest as the principal of Mountain Heights Academy and recused herself from this agenda item, handed over the responsibilities of chair to Vice Chair Bowles, then left the meeting.

Representatives of Utah Connections Academy discussed the size of their waitlist and the need the community needs.

Representatives of Utah Virtual Academy also discussed their waitlist and needs of parents in the community during these unique times.
